

CALUMET COUNTY FAIR BUILDING USE POLICY

PURPOSE OF THE ASSOCIATION:

The purpose of the CALUMET COUNTY AGRICULTURAL ASSOCIATION is to promote educational opportunities for youth and adults in Calumet County. These educational opportunities are not limited to the education of agricultural, mechanical, or household arts. This purpose is accomplished through exhibitions, workshops, fairs, and events consistent with the needs of the people in Calumet County and members of this Association. The building and grounds usage is allowed solely at the desecration of the CALUMET COUNTY AGRICULTURAL ASSOCIATION.

BUILDING USE:

As a non-profit organization, it is essential that building maintenance and sound management practices be followed. Therefore, a building use policy has been established. In an effort to assist with educational programs, the rental fee may be modified, but the security deposit is required. That deposit will be returned if the grounds and buildings used are cleaned by the User group. All groups will be required to write **TWO CHECKS**, one for the security deposit and one for the building and grounds rental.

ALL BUILDINGS AND GROUNDS RENTAL WILL REQUIRE A SECURITY DEPOSIT. NO CAMPING ALLOWED UNLESS A CONDITIONAL USE PERMIT WAS OBTAINED. A CERTIFICATE OF INSURANCE IS REQUIRED WHEN CONTRACT IS RETURNED. USER MUST MAKE ARRANGEMENTS TO DISPOSE OF ANY WASTE. IF AN ORGANIZATION LEAVES ANY GARBAGE LEFT ON THE PREMISES FOR THE ASSOCIATION TO DISPOSE OF A FEE WILL BE CHARGED FOR THE REMOVAL OF SUCH WASTE.
